





# **SAFETY INFORMATION**

Please read and understand this entire manual before attempting to assemble, operate or install the product.

#### **PREPARATION**

Before beginning assembly of product, make sure all parts are present. Compare parts with package contents list and hardware contents list. If any part is missing or damaged, do not attempt to assemble the product.

Note: Horizontal support bar should be located on the outside of the kennel once assembled.

**Estimated Assembly Time: 1 hour** 

Two people required for assembly of this kennel.

Tools Required for Assembly (not included): 9/16 in. wrench or socket wrench

### **ASSEMBLY INSTRUCTIONS**

 Start by planning your layout and the placement of your gate. Start construction of your panel kennel at a corner. Stand up two chain link panels (B) to create a corner. Use two panel clamps (AA) to secure panels together. Place a clamp approximately 4 inches from the top and bottom of the panel. Tighten clamps. Position clamps with the smooth bolt head inward toward pet.


Note: Kennel can be built in a 10 ft. x 10 ft. configuration or a 5 ft. x 15 ft. depending on panel placement.




2. Attach the next panel (B) in line using two panel clamps (AA). Two panels (B) together will complete a 10 ft. kennel side.

Note: If you are building as a 5 ft. x 15 ft. configuration then 3 panels will complete a 15 ft. side.

### **ASSEMBLY INSTRUCTIONS**

3. Create another corner by adding another panel (B) at 90°. Use the gate panel (A) and another panel (B) to complete this side.

Note: The gate panel (A) can be used in any position around the kennel.






4. Continue by adding three more panels (B) and eight clamps (AA) to complete kennel construction. Tighten all clamps (AA).

#### ONE YEAR LIMITED WIRE KENNEL WARRANTY

### What is Covered

The manufacturer warrants that the kennel will be free from defects in workmanship for a period of one (1) year. This warranty is extended only to an original purchaser who installed the product at a residence (not commercial premises) in the 50 United States. It is not transferable.

If a defect exists, the manufacturer will, at its option, either repair or replace the product or the defective component. This warranty does not cover the costs of labor to remove a defective product or component or install any replacement product or component.

This warranty shall not apply to defects or damages caused by mishandling, improper installation or installation not in accordance with the instructions provided with the product, alteration, removal or re-installation, improper or unreasonable use, maintenance or storage, use of incompatible accessories, accident, impact by foreign objects, fire, acts of God or normal wear and tear.

No person is authorized to extend or otherwise modify this Warranty.
